The State Institute for Rehabilitation, Training and Research (SIRTAR) has been setup as an autonomous body under the administrative control of Social Justice and Empowerment Department, Govt. of Haryana with the main objective to provide educational as well as rehabilitation services to persons with special needs for their mainstreaming in the society, to develop trained manpower in the field of special education & disability rehabilitation and to undertake research in the field of Mental Retardation, Cerebral Palsy, Autism & Multiple Disabilities. Why CRE

As you may be aware that each professional & personal working in the field of disability rehabilitation must be registered with Rehabilitation council of India, New Delhi u/s 19 of the RCI Act of 1992 and registration must be renewed after every five years. It is mandatory to get 100 CRE point within 5 years for renewal of registration. One hour of CRE programme comprises 1 point and therefore, renewal of the registration after 5 years, one need to attend minimum of 17 days CRE programme.
